

Bylaw # 01/10
Village of Bittern Lake
Province of Alberta

A Bylaw of the Village of Bittern Lake in the Province of Alberta amends Bylaw # 01/09 which provides for the Rates, Fees and Charges within the said Village or cited as the Utility Rate Bylaw.

Referencing Schedule “A” Rates, Fees, and Charges:

And whereas, the council of the Village of Bittern Lake deems it advisable to pass a bylaw to amend the current Utility Rate bylaw #01/09 to change the Rates and amend payment timelines.

Now therefore, the municipal council of the Village of Bittern Lake duly assembled enacts that Bylaw #01/09 be amended to add the following clauses pertaining to Schedule “A” Rates, Fees and Charges;

SECTION 40 UTILITY AND ENVIRONMENTAL SERVICES

- (A) Utility, garbage and recycling charges will be billed on a monthly basis and are due and payable by the second last business day of the month of billing.
- (B) All outstanding charges will receive a 10% penalty per month, which will be added to and form part of the utility charges.
- (C) Should any combined water and sewer account or portion thereof remain unpaid for more than 90 days following the date of billing, the service will be disconnected.
- (D) Where it has become necessary to discontinue service for non-payment of an account, reconnection will not be made until all arrears and penalties are paid in full and an additional \$ 25.00 reconnection charge will be payable in advance.
- (E) N.S.F. Cheques – a penalty of \$ 25.00 will be imposed on any customer issuing a NSF cheque to the Village of Bittern Lake.
